MBA Scholarships for Outstanding International Students*

The Faculty of Business offers eight scholarships in each academic year for MBA by Coursework international students. Four scholarships per semester, per year will be awarded in the Autumn and Spring Semesters each year.

One scholarship in each semester will be awarded to a **commencing** MBA international student and three scholarships will be awarded to a **current** MBA international student who has completed one full semester of study in the MBA course.

Scholarships will be awarded solely on the basis of academic merit. If no applicant satisfies the award conditions then the scholarship will not be awarded.

SCHOLARSHIPS FOR COMMENCING STUDENTS

For commencing students each scholarship will be awarded based solely on academic results achieved by the applicant in their undergraduate degree.

Scholarship Details

- > Two scholarships of A\$5,000 will be available in each academic year (one each semester);
- > The scholarship will be awarded through a reduction of tuition fees.
Scholarships will be awarded to the applicant who is the highest achiever;
- > No correspondence will be entered into.

Eligibility

Candidates must:

1. have applied for admission to the UTS MBA award, course code C04018;
2. be categorised by UTS as an international student; and
3. have reached a level of achievement across all subjects in their undergraduate qualification used as a basis for admission to the MBA which is equivalent to/or above an academic achievement of Distinction average (75%) (all subjects studied will be counted).

SCHOLARSHIPS FOR CURRENT STUDENTS

MBA Scholarships refer to current UTS:Business MBA international students who have completed their first semester of study.

There are six scholarships available each year for current international MBA students worth A\$2000 each (three each semester).

Eligibility

Candidates must:

1. be enrolled as a full-time international student in four subjects.
2. not have received a scholarship from UTS:Business previously.
3. not be a current scholarship student/holder at UTS.

Selection Criteria

Will be based on academic merit.
